## PREACH & TEACH: **Civic Discipleship**

**Civic Discipleship** is the marriage between civic participation and faith that is rooted in the conviction that deep civic engagement is because of one's faith, not in spite of it.

### **Civic Discipleship Involves:**

- Building relationships with elected officials
- Educating the community about the issues that matter most
- Working to remove all voting barriers
- Creating relational motivation to participate in the elections
- Creating practical tips for exercising faith by protecting vulnerable voters.

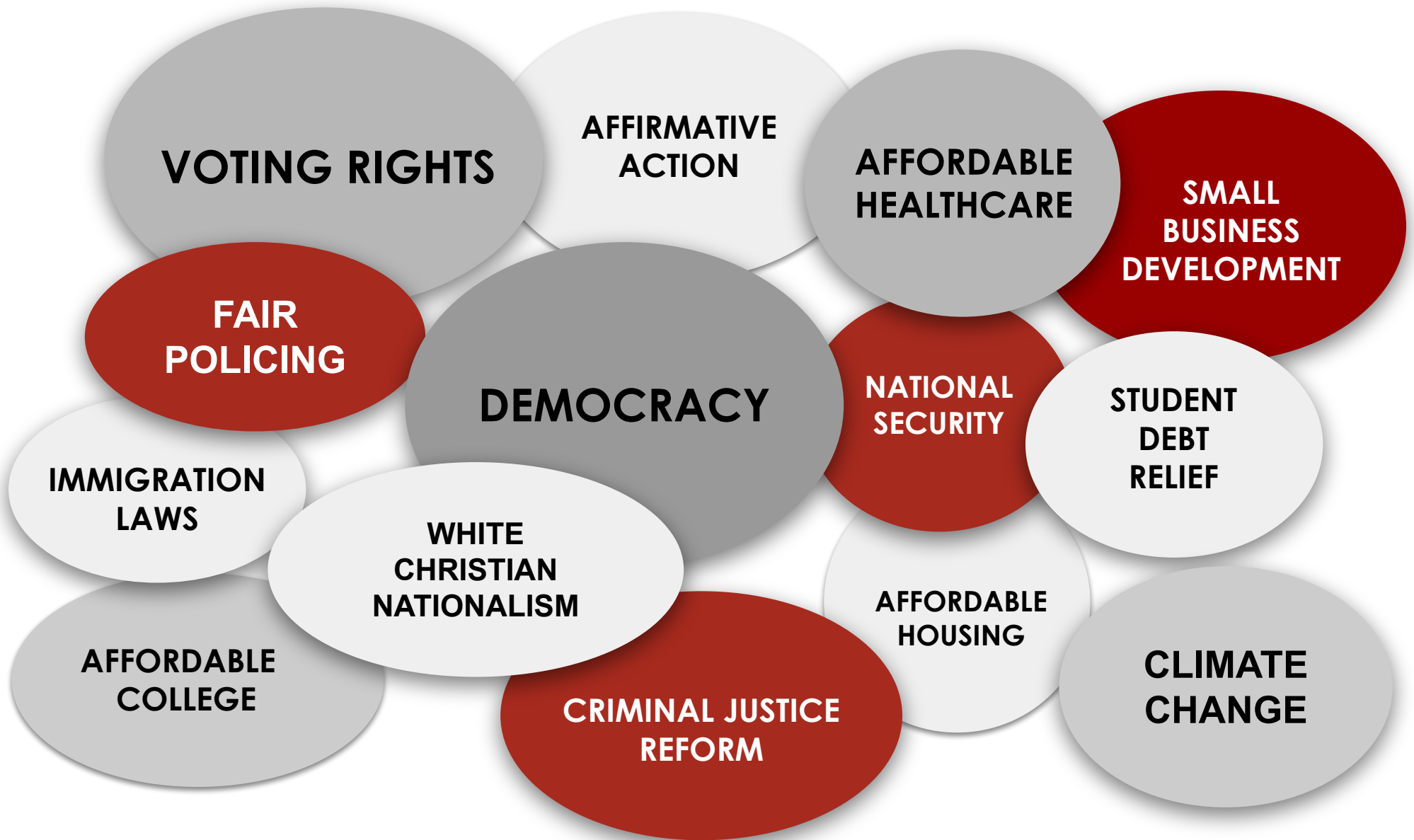
- **Not voting** is voting against your own interests.

## TEACH: The Challenges Of Ex-Felon Voting

- **1 of 19 voting age African Americans** are disenfranchised as ex-felons. (3.5 times more than non-African Americans).
- **In 10 states**, including California, **Latinos** were 3 times more likely to lose their right to vote from felony disenfranchisement than the population at large.

**PURGED VOTING ROLLS** | 17 million U.S. Voters Purged (2016 – 2018)

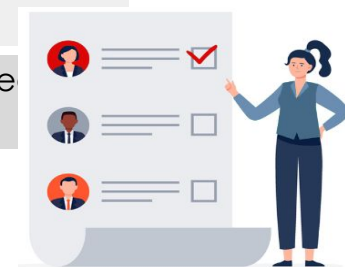

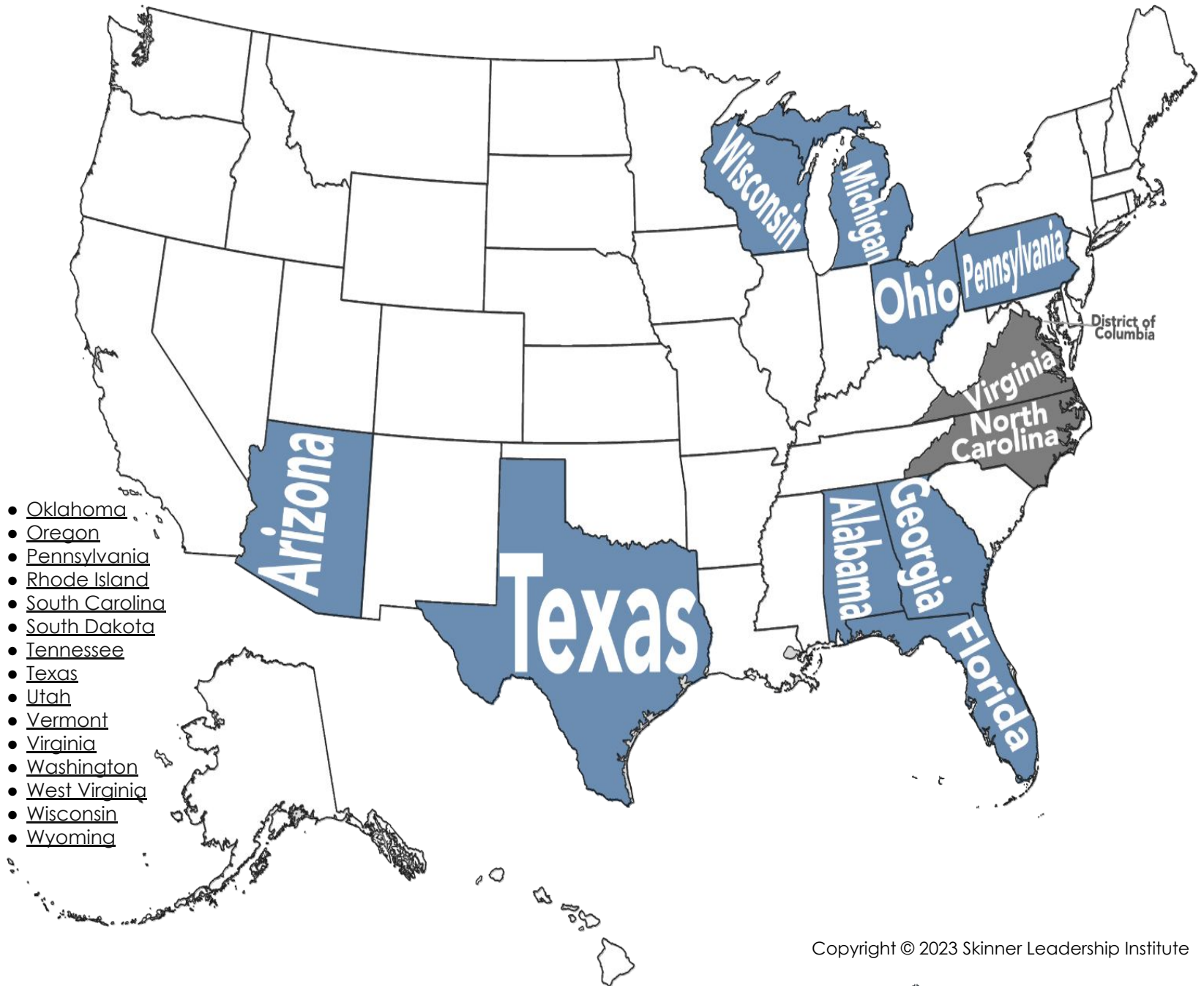

- Communicate to Election Officials: The Faith community **“will be watching”** to ensure free, fair, and safe elections

EDUCATE	<b>Teach the issues on the ballot</b> impacting your members.
REGISTER	Make sure your <b>congregation is fully registered</b> .
PRAY	<b>Pray</b> now until election day 2024.
CONDUCT	<b>Post on Social Media</b> encouraging voter turnout.
HOST	<b>Host Turnout Sunday</b> Service (Sunday, November 3, 2024)
PLAN	<b>Plan transportation for elderly</b> & disabled members to vote.
POST	<b>Post Polling Sites</b> & changes up to Election Day
WATCH	Have your faith leaders <b>visit polling sites of your members</b> .
ADOPT	<b>Adopt a precinct</b> near you church.
CANVASS	<b>Go door to door in your community</b> to encourage voting

## IRS GUIDELINES FOR HOUSES OF WORSHIP



**REJECT**

**DO:** Publish news stories about campaigns...the congregation must be kept informed as best as possible. Also, discuss candidates position on issues with congregation.

**DO:** Rent out the faith organization facilities (e.g. kitchens, athletic facilities, community rooms) for political activities...regular rates **MUST** apply.

**DO:** Provide rentals of membership lists at regular rates.

**DO:** Allow candidates to make appearances at the organization's events/services.

**DO:** Distribute candidate campaign literature as an individual faith leader.

**DO:** Distribute candidate surveys and/or voting records of office holders.

**DO:** Publish political ads; Apply regular rates.

**DO:** Use organization's vehicle to transport voter.

**DO:** Lobby & Campaign for or against legislation as congregation or individual.

**DO NOT:** Support or oppose the candidates on the congregation's behalf.

**DO NOT:** Use the congregation's funding to give financial contributions of any kind to the candidates/office holders.

**DO NOT:** Impose your opinions on the congregation.

**DO NOT:** Publish faith organization editorials that support or oppose candidates.

**DO NOT:** Publish political ads as a donation.

**DO NOT:** Display candidate's literature on organization's vehicle used to transport people to vote.

**DO NOT:** Distribute candidate campaign literature as a congregation.

The prophet Amos reminds us to “let justice roll down like waters and righteousness like an ever-flowing stream.” This year, we will be participating with interfaith communities across the nation in the **Faiths United to Save Democracy** preparation for the upcoming elections. We have the power to vote for leaders who will support life-sustaining programs, for our community.

- **With voting**, Social Security, Medicare, Medicaid, Lower Prescription Drug Costs, police/community relations, Supplemental Nutrition Assistance Program (SNAP/Food Stamps) and other financial stability programs are protected with our high turnout.

I ask each of you to commit to **encourage 5 family members, friends, and co-workers to vote on Election Day** and make sure they get to the polls. ## SHARE: Sample Sermon Scriptures

### God's Concern for Justice, the Poor, and the "Least of These"

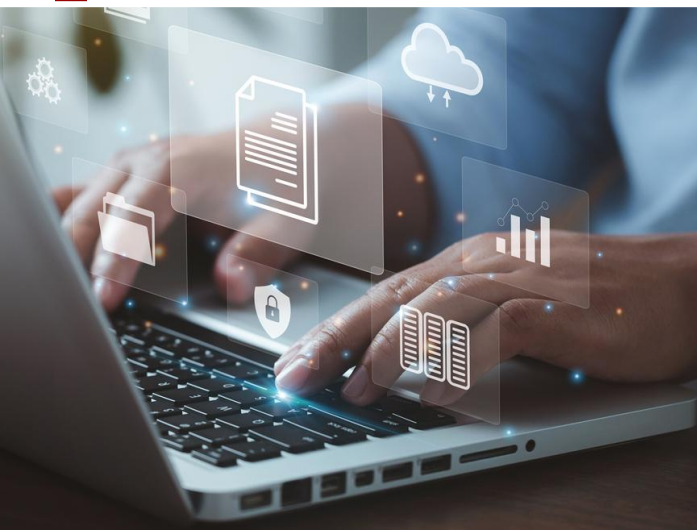

### Motivating factors for younger voters in the 2020 election:

- **Racial justice and systemic racism** was reported as the **top issues**.
- **18 – 35 yr old voters** - are the nation's largest, most diverse voting bloc.
- **53-55%** of registered 18-29 year old voters **voted in 2020** (*up 11% from previous general elections*)
- **80% supported the racial justice movement** and the George Floyd protests
- **1.1M** registered in the first half of June 2020 in the summer of protests

## LEARN: How to Engage Younger Voters

**For young people, voting is important when it is connected to their issues!**

- They respond to important issues like climate justice, criminal justice, student debt forgiveness.
- Issues are more important than political personality, or political party.
- Messages on key issues resonate
- They will participate when they believe it will lead to meaningful change and it is connected to their issues.
